**Sub: Release of Grants-in-aid) to the State Government of Meghalaya as First Tranche of 2<sup>nd</sup> instalment (Programme fund under World Bank) under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the year 2020-21-reg.**

Sir,

I am directed to convey the sanction of the President to the payment of Grants-in-aid amounting to **Rs.160,35,50,000 (Rupees One Hundred and Sixty Crore and Thirty Five Lakh and Fifty Thousand only)** to the State Government of Meghalaya as First Tranche of 2<sup>nd</sup> instalment of Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) towards the Financial Year 2020-21.

2. The total amount of **Rs.160.355 crore** being released in the present sanction has been adjusted as per the details given below:

The State Government shall transfer these funds along with the corresponding State Share to **Meghalaya State Rural Road Development Agency (MSRRDA) within a maximum days of 15 days from the date of receipt of these funds.** In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. The State Government is required to endorse a copy of the release order to the Government of India at the following address:-

4. Meghalaya State Rural Road Development Agency (MSRRDA) has nominated **Shri. T. G. Nengnong** as the Empowered Officer of Meghalaya Rural Roads Development Agency (MSRRDA).

5. The funds released by the State Government shall be kept in a separate Savings **Bank Account No. 10407610364 (IFSC Branch Code No. SBIN0006320), State Bank of India, Meghalaya Secretariat, MG Road, Shillong-793001.** It shall be ensured by the Meghalaya State Rural Road Development Agency (MSRRDA) that the Programme Implementing Units (PIUs) in the districts have access to the funds and

the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of Meghalaya State Rural Road Development Agency (MSRRDA) shall communicate to the bank the names of the Authorised Signatories, who will be issuing cheques on the Agency's said bank account for the purpose of this sanction.

6. The Empowered Officer shall issue standing instructions to the bank regarding the names of authorized payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.

7. No Utilization Certificate is pending from **Meghalaya State Rural Road Development Agency (MSRRDA)**.

8. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose.

9. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211(1) of the General Financial Rules.

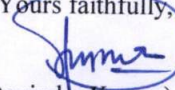
10. The expenditure is debit to the following Head of Accounts under **Demand No.85** Department of Rural Development (2020-21).
