**Subject: Release of Administrative Fund to the State Government of Odisha under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the year 2019-20 – reg.**

Sir,

1.1 I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to **Rs.4,71,70,000/- (Rupees Four Crore Seventy One Lakh and Seventy Thousand only)** to the State Government of Odisha as Central Assistance towards Administrative Fund under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the **Financial Year 2019-20**.

1.2 The amount of Rs. 4.717 Crore is towards 1<sup>st</sup> installment of Administrative Fund Allocation made to the State Government of Odisha for the year 2019-20.

2. The State Government must transfer these funds to **Odisha State Rural Road Agency (OSRRA)** within 3 working days positively from the date of receipt of these funds.

3. **Odisha State Rural Road Agency (OSRRA)** has nominated **Shri Chandramouli Pattnaik, Chief Engineer (PMGSY)** as the Empowered Officer of Odisha State Rural Road Agency (OSRRA). The State Government is required to endorse a copy of the release order to the Government of India at the following address:

4. The funds transferred by the State Government to OSRRA shall be kept in a separate **Saving Bank Account No. 10872161880 (Branch Code-0041, IFS Code-SBIN0000041, MICR code-751002002) in the State Bank of India, Bhubaneswar Main Branch, Odisha-751009**. It shall not be transferred to any other account of the Agency without approval. It shall be ensured by the State Government that the Programme Implementing Units (PIUs) in the districts have ready access to the funds and the funds held in the specified account are allowed to be utilized only by the Executive Agency/Agencies only for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of **Odisha State Rural Road Agency (OSRRA)** shall communicate to the Bank, the names of the Authorized Signatories, who will be issuing cheques on the Agency's bank account for the purpose of this sanction.

5. The Empowered Officer shall issue standing instructions to the Bank regarding the names of Authorized Payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.




6. No Utilization Certificate is pending from Odisha State Rural Road Agency (OSRRA).
7. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose.
8. The Accounts of the grantee institution will be audited by the Comptroller and Auditor General of India and the internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211 (1) of the General Financial Rules.
9. The expenditure is debitable to the following Head of Accounts under **Demand No.84** Department of Rural Development (2019-2020):
