I am directed to convey the sanction of the President to the payment of Grants-in-aid (Programme Fund) amounting to **Rs. 300,00,00,000/-** (*Rupees Three Hundred crore only*) to the State Government of Arunachal Pradesh as Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the Financial Year 2021-22.

2. The Total amount of **Rs. 300 crore** is being released towards as an additional fund (3rd installment) Indicative Annual Allocation for the year 2021-22 in the following manner:-

3. The State Government shall transfer these funds along with the corresponding State Share to Arunachal Rural Roads Development Agency (ARRDA) a maximum period of 15 days from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. The State Government is required to endorse a copy of the release order to the Government of India at the following address.

- 4. Arunachal Rural Roads Development Agency (ARRDA) has nominated Shri D. Nyodu, Chief Engineer, Rural Works Department, as the Empowered Officer.
- 5. The funds released by the State Government shall be kept in a separate Savings Bank Account No. 10940060635 (IFSC Branch Code No. SBIN0006091), State Bank of India, Itanagar Branch, Arunachal Pradesh. It shall be ensured by the Arunachal Rural Roads Development Agency (ARRDA) that the Programme Implementing Units (PIUs) in the districts have access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana.
- 6. The Empowered Officer of Arunachal Rural Roads Development Agency (ARRDA) shall communicate to the bank the names of the Authorized Signatories, who will be issuing cheques on the Agency's said bank account for the purpose of this sanction

- 7. The Empowered Officer shall issue standing instructions to the bank regarding the names of authorized payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.
- 8. No Utilization Certificate is pending from Arunachal Rural Roads Development Agency (ARRDA).
- 9. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose.
- 10. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the O/o the CCA, Ministry of Rural Development in terms of **Rule 236 (1)** of the General Financial Rules.
- 11. The expenditure is debitable to the following Head of Accounts under **Demand No.86** Department of Rural Development (2021-22).
