- 4. Bihar State Road Development Corporation Limited (BSRDC) has nominated Shri Sanjay Kumar, Chief General Manager, BSRDC, Patna, Bihar as Empowered Officer.
- 5. The funds will be transferred by the State Government to Bihar State Road Development Corporation Limited (BSRDC) shall be kept in separate Savings Bank Account No. 37472808234 (IFSC Branch No. SBIN0006379), State Bank of India, Bailey Road Branch, Vishweshwaraiya Bhawan, Patna, Bihar. It shall not be transferred to any other account of the Agency without approval. It shall be ensured by the State Government that the Programme Implementation Units (PIUs) in the districts have ready access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing

Agency/Agencies only for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of the Bihar State Road Development Corporation Limited (BSRDC) shall communicate to the Bank, the names of the Authorized Signatories, who will be issuing cheques on the Agency's Bank account for the purpose of this sanction.

- 6. The Empowered Officer shall issue standing instructions to the Bank regarding the names of Authorized Payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.
- 7. No Utilization Certificate is pending from Bihar State Road Development Corporation Limited (BSRDC).
- 8. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 236 (1) of the General Financial Rules.
