Subject – Release of 2nd Tranche of 2nd installment Grants-in-aid to State Government of Chhattisgarh under Pradhan Mantri Gram Sadak Yojana (PMGSY) towards Programme Fund for the year 2021-22.

Sir,

I am directed to convey the sanction of the President to the payment of Grants-in-aid amounting to **Rs.94,09,28,500/- (Rupees Ninety Four Crore Nine Lakh and Twenty Eight Thousand Five Hundred Only)** to the State Government of Chhattisgarh as 2nd Tranche of 2nd installment of Programme Fund as Central Assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the Financial Year 2021-22.

2. The amount of **Rs.94.09285 crore** will be adjusted under the following Phase:-

3. The State Government shall transfer these funds along with the corresponding State share to Chhattisgarh Rural Road Development Agency (CGRRDA) within a maximum period of 15 days from the date of receipt of these funds. In case of non transfer beyond this period, Central Government may be constrained to stop further releases. The State Government is requested to endorse the copy of the release order to the Central Government addressed as under:-

4. Chhattisgarh Rural Road Development Agency (CGRRDA) has nominated **Shri Alok Katiyar CEO, as Empowered Officer** of Chhattisgarh Rural Road Development Agency (CGRRDA), Civil Lines, Raipur.

5. The funds released by the State Government shall be kept in a separate **Savings Bank Account No.10038940538 (IFS Code No.SBIN0004440), State Bank of India, Specialized Housing Finance Branch, Zonal Office Campus, Byron Bajar, Civil Lines, Raipur-492001, Chhattisgarh**. It shall be ensured by the Chhattisgarh Rural Road Development Agency (CGRRDA) that the Programme Implementing Units (PIUs) in the districts have access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies for the purpose of

approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of Chhattisgarh Rural Road Development Agency (CGRRDA) shall communicate to the bank the names of the Authorized Signatories, who will be issuing cheques on the Agency's bank account for the purpose of this sanction.

6. The Empowered Officer shall issue standing instructions to the bank regarding the names of authorized payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.

7. No Utilization Certificate is pending from Chhattisgarh Rural Road Development Agency (CGRRDA).

8. Utilization Certificate should be submitted within 12 (twelve) months of the closure of the financial year which shall include interest accrued. Interest accrued should be computed based on the details of the ledger accounts for the purpose.

9. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of **Rule 236(1)** of the General Financial Rules.


