- 4. The funds transferred by the State Government to KRRDA shall be kept in a separate Savings Bank Account No. 043621700000022 in Syndicate Bank, J-652, Near Navrang Talkies, Dr. Rajkumar Road, Rajajinagar II Stage, Bangalore-560010 (IFSC Code No. SYNB0000436), Karnataka.
- 5. The KRRDA shall utilize the amount released under Administrative Fund as per Para 12.2 of the Programme Guidelines.
- 6. No Utilization Certificate is pending from Karnataka Rural Roads Development Agency (KRRDA).
- 7. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose.
