- 4. Karnataka Rural Road Development Agency (KRRDA) has nominated **Shri Prabhakar D Hamigi, Chief Engineer as the Chief Operating Officer of KRRDA**. The State Government is required to endorse a copy of the release order to the Government of India at the following address:-

- The funds released by the State Government shall be kept in a separate Savings Bank Account No.04362170000018 in Canara Bank, Rajajinagar II Stage, Banglore-560010 (IFSC Code No. CNRB0010436), Karnataka. It shall be ensured by the Karnataka Rural Road Development Agency (KRRDA) that the Programme Implementing Units (PIUs) in the districts have access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana-III. The Chief Operating Officer of Karnataka Rural Road Development Agency (KRRDA) shall communicate to the bank the names of the Authorized Signatories, who will be issuing cheques on the Agency's said bank account for the purpose of this sanction.
- 6. The Chief Engineer as the Chief Operating Officer of KRRDA shall issue standing instructions to the bank regarding the names of authorized payees and their designated account details and the amounts

- 7. No Utilization Certificate is pending from Karnataka Rural Road Development Agency (KRRDA).
- 8. The Utilization Certificate should be submitted within 12 (twelve) months of the closure of the financial year which shall include interest accrued. Interest accrued should be computed based on the details of the ledger accounts for the purpose.
- 9. The State Nodal Agency shall ensure that the interest earned from the funds released should be mandatorily remitted to the respective Consolidated Funds on pro-rata basis in terms of Rule 230 (8) of GFR, 2017. Interest earned should be clearly and separately depicted in PFMS, scheme-specific portals integrated with PFMS and MIS provided by the banks.
- 10. The Accounts of the grantee institution will be audited by the Comptroller and Auditor General of India and the internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 236 (1) of the General Financial Rules (GFR).
