**Subject: Release of 0.125 crore as 1<sup>st</sup> Tranche of 2<sup>nd</sup> installment of Central Share of programme fund to the State of Madhya Pradesh for Road Connectivity Project on Left Extremism Area(RCPLWEA) under PMGSY for the Financial Year 2021-22-reg.**

Sir,

I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to **Rs.12,50,000/- (Rupees Twelve Lakh Fifty Thousand only)** to the State Government of Madhya Pradesh for Road Connectivity Project on Left Extremism Area (RCPLWEA) as 1<sup>st</sup> Tranche of 2<sup>nd</sup> installment as Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the **Financial Year 2021-22**.

2. The amount of **Rs. 0.125 Crore** being released will be adjusted under the following Phase:

3. The State Government must transfer these funds along with corresponding State share to **Madhya Pradesh Rural Road Development Authority (MPRRDA) within a maximum period of 15 days from the date of receipt of these funds**. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. The State Government is required to endorse a copy of the release order to the Government of India at the following address:

4. Madhya Pradesh Rural Roads Development Authority (MPRRDA) has **nominated Ms. Tanvi Sundriyal, Chief Executive Officer, MPRRDA as the Empowered Officer.**

5. The funds transferred by the State Government to MPRRDA shall be kept in a separate **saving Bank Account No. 1793139758 in Central Bank of India (IFSC Code-CBIN0283312), 9 Arera Hills Branch, Bhopal, Madhya Pradesh**. It shall be ensured by **Madhya Pradesh Rural Roads Development Authority (MPRRDA)** that the Programme Implementation Units (PIUs) in the districts have ready access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies only for the purpose of approved works under the

Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of the **Madhya Pradesh Rural Roads Development Authority (MPRRDA)** shall communicate to the Bank, the names of the Authorised Signatories, who will be issuing cheques on the Agency's Bank account for the purpose of this sanction.

6. The Empowered Officer shall issue standing instructions to the Bank regarding the names of Authorized Payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.

7. No Utilization Certificate is pending from **Madhya Pradesh Rural Roads Development Authority (MPRRDA), Bhopal**.

8. The Accounts of the grantee institution will be audited by the Comptroller and Auditor General of India and the internal Audit of the Principal Accounts Office of the Ministry in terms of **Rule 236 (1)** of the General Financial Rules.

9. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose.


10. The expenditure is debit to the following Head of Accounts under **Demand No.86** Department of Rural Development (2021-22):

11. The Section Officer, PMGSY, Ministry of Rural Development, New Delhi (208139) will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para-1 above will be transferred to State Government of Madhya Pradesh.
