**Subject: Release of Rs 97.75 Crore to State Government of Odisha as 2<sup>nd</sup> tranche of 2<sup>nd</sup> installment of Annual Allocation under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the Financial Year 2021-22 – reg.**

Sir,

I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to **Rs. 97,75,00,000/- (Rupees Ninety Seven Crore and Seventy Five Lakh only)** to the State Government of Odisha as 2<sup>nd</sup> Trench of 2<sup>nd</sup> installment of Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) Programme Fund for the **Financial Year 2021-22.**

2. The amount of Rs. 97.75 crore released in the present sanction is adjusted as per the details given below:

The State Government must transfer these funds along with the corresponding State Share to **Odisha State Rural Road Agency (OSRRA)** within a maximum days of 15 days from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. The State Government is required to endorse a copy of the release order to the Government of India at the following address:

4. **Odisha State Rural Road Agency (OSRRA)** has nominated **Er. Akshaya Kumar Padhan, Chief Engineer (PMGSY)** as the Empowered Officer of Odisha State Rural Road Agency (OSRRA).

5. The funds transferred by the State Government to OSRRA shall be kept in a separate saving **Bank Account No. 10872161766 (IFS Code: SBIN0000041) in State Bank of India, Bhubaneswar Main Branch, District Khurda, Odisha –751009.** It shall be ensured by **Odisha State Rural Road Agency (OSRRA)** that the Programme Implementation Units (PIUs) in the districts have ready access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies only for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of the **Odisha State Rural Road Agency (OSRRA)** shall communicate to the Bank, the names of the Authorised Signatories, who will be issuing cheques on the Agency's Bank account for the purpose of this sanction.

6. The Empowered Officer shall issue standing instructions to the Bank regarding the names of Authorized Payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.

7. No Utilization Certificate is pending from Odisha State Rural Road Agency (OSRRA).

8. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose.

9. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 236(1) of the General Financial Rules.

10. The expenditure is debit to the following Head of Accounts under **Demand No.86** Department of Rural Development (2021-22).
