Subject: Release of 1st installment of Programme fund to the State Government of Rajasthan under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the year 2020-21 reg.

Sir,
I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to Rs.132,17,00,000/- (Rupees One Hundred Thirty Two Crore and Seventeen Lakh only) as 1st installment of Central assistance towards Programme Funder under Pradhan Mantri Gram Sadak Yojana (PMGSY) to the State of Rajasthan for the Financial Year 2020-21.

2 The amount of Rs 132.17 crore is being adjusted as per the details given below:

3 The State Government must transfer these funds along with the corresponding State Share to **Rajasthan Rural Roads Development Agency (RRRDA)** within a maximum days of 15 days from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. The State Government is required to endorse a copy of the release order to the Government of India at the following address:

4. **Rajasthan Rural Roads Development Agency (RRRDA)**, has nominated **Shri Subodh Malik, Chief Engineer (PMGSY)** as the Empowered Officer of RRRDA.

5. The funds transferred by the State Government to RRRDA shall be kept in a separate **Saving Bank Account No. 10000951803 in State Bank of Bikaner & Jaipur (Branch Code No: 1820), (IFS Code-SBBJ0010820) PWD Complex, Jacob Road, Jaipur.** It shall not be transferred to any other account of the Agency without approval. It shall be ensured by the State Government that the Programme Implementation Units (PIUs) in the districts have ready access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies only for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of the **Rajasthan Rural Road Development Agency**

(RRRDA), shall communicate to the Bank, the names of the Authorised Signatories, who will be issuing cheques on the Agency's Bank account for the purpose of this sanction.

6. The Empowered Officer shall issue standing instructions to the Bank regarding the names of Authorized Payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.

7. No Utilization Certificate is pending from **Rajasthan Rural Road Development Agency (RRRDA), Jaipur.**

8. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose.

9. The Accounts of the grantee institution will be audited by the Comptroller and Auditor General of India and the internal Audit of the O/o the CCA of the Ministry of Rural Development in terms of Rule 236 (1) of the General Financial Rules.

10. The expenditure is debitable to the following Head of Accounts under **Demand No. 85** Department of Rural Development (2020-21).
