- 4. Rajasthan Rural Roads Development Agency (RRRDA), has nominated Shri Subodh Malik, Chief Engineer (PMGSY) as the Empowered Officer of RRRDA.
- 5. The funds transferred by the State Government to RRRDA shall be kept in a separate Saving Bank Account No. 10000951803 in State Bank of Bikaner & Jaipur (Branch Code No: 1820), (IFS Code-SBBJ0010820) PWD Complex, Jacob Road, Jaipur. It shall not be transferred to any other account of the Agency without approval. It shall be ensured by the State Government that the Programme Implementation Units (PIUs) in the districts have ready access to the funds and the funds held in the specified account are allowed to

The Empowered Officer of the Rajasthan Rural Road Development Agency (RRRDA), shall communicate to the Bank, the names of the Authorised Signatories, who will be issuing cheques on the Agency's Bank account for the purpose of this sanction.

- 6. The Empowered Officer shall issue standing instructions to the Bank regarding the names of Authorized Payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.
- 7. No Utilization Certificate is pending from Rajasthan Rural Road Development Agency (RRRDA), Jaipur.
- 8 The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose.
- 9. The Accounts of the grantee institution will be audited by the Comptroller and Auditor General of India and the internal Audit of the O/o the CCA of the Ministry of Rural Development in terms of Rule 236 (1) of the General Financial Rules.
