Sub: Release of 2nd tranche of 1st installment of Programme Funds to State Government of Tamil Nadu under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the year 2021-22.

Sir,

1.1 I am directed to convey the sanction of the President to the payment of Grants-in-aid amounting to **Rs 110,00,00,000 Cr. (Rupees One Hundred ten Crore only)** to the State Government of Tamil Nadu as 2nd tranche of 1st instalment of Central assistance for the Financial Year 2021-22.

1.2 The amount of Rs. 110.00 crore towards balance payment (2nd Tranche) of 1st installment is adjusted as per the details given below:-

2. The State Government shall transfer these funds along with the corresponding State Share to Tamil Nadu Rural Housing and Infrastructure Development Corporation (TNRHIDC) within a maximum period of 15 days from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases.

3. The next Tranche/Installment of funds would be released only after Reconciliation of OMMAS with Manual Books of Account and 100 % credit of Maintenance fund for roads under DLP.

4. Tamil Nadu Rural Housing and Infrastructure Development Corporation (TNRHIDC) has nominated Shri Praveen P. Nair, Director, Directorate of Rural Development & Panchayat Raj Department, Panagal Building, Saidapet, Government of Tamil Nadu as the Empowered Officer. The State Government is required to endorse a copy of the release order to the Government of India at the following address:-

5. The funds released by the State Government shall be kept in a separate Savings Bank Account No.10885934245 (IFSC Branch Code No.SBIN0013241), State Bank of India, Small and Medium Enterprises (SME) Branch Chennai, 39, 6th Floor, Prasanth Gold Towers, T Nagar, Chennai-600017 Tamil Nadu. It shall be ensured by the Tamil Nadu Rural Housing and Infrastructure Development Corporation that the Programme Implementing Units (PIUs) in the districts have access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of Tamil Nadu Rural Housing and Infrastructure Development Corporation (TNRHIDC) shall communicate to the bank the names of the Authorized Signatories, who will be issuing cheques on the Agency's said bank account for the purpose of this sanction.

6. The Empowered Officer shall issue standing instructions to the bank regarding the names of authorized payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.

7. No Utilization Certificate is pending from **Tamil Nadu Rural Housing and Infrastructure Development Corporation (TNRHIDC)**.

8. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose.

9. The Accounts of the grantee institution will be audited by the Comptroller and Auditor General of India and the internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 236 (1) of the General Financial Rules (GFR).

10. The expenditure is debitable to the following Head of Accounts under **Demand No. 86** Department of Rural Development (2021-22).
