In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. - Telangana Road Connectivity Project for Left Wing Extremism Affected Areas 4. (TSRCPL WEA) Scheme under R &B Department has nominated Shri Pingali Satish, Chief Engineer (R&B) Admn, O.C, D&P, LWE, RSW & RR & Empowered Officer, TSRCPLWEA.
- The funds released by the State Government shall be kept in a separate saving Bank Account No. 37594497421 (IFSC Code-SBIN0013272), State Bank of India, Erragadda Branch 13272, #5-264, Beside SriRamulu Theatre, Prem Nagar, Erragadda, Hyderabad-500018. It shall be ensured by Telangana Road Connectivity Project for Left Wing Extremism Affected Areas (TSRCPL WEA) Scheme under R &B Department that the Programme Implementation Units (PIUs) in the districts have access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies only for the purpose of approved works under the Road Connectivity Project for Left Wing Extremism Affected Areas (RCPLWEA). The Empowered Officer of the Telangana Road Connectivity Project for Left Wing Extremism Affected Areas (TSRCPL WEA) Scheme under R &B Department shall communicate to the Bank, the names of the Authorised Signatories, who will be issuing cheques on the Agency's Bank account for the purpose of this sanction.
- The Empowered Officer shall issue standing instructions to the bank regarding the 6. names of authorized payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.
- The Accounts of the grantee institution will be audited by the Comptroller and Auditor 7. General of India and the internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 236 (1) of the General Financial Rules (GFR).
- The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose.
