Subject: Release of 2nd Tranche of 1st installment of Administrative fund to the State Government of Uttarakhand under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the Financial Year 2020-21 reg.

Sir,

I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to **Rs.4,23,50,000/- (Rupees Four Crore Twenty Three Lakh and Fifty Thousand only)** as 2nd Tranche of 1st installment of Central assistance towards Administrative Funder under Pradhan Mantri Gram Sadak Yojana (PMGSY) to the State of Uttarakhand for the **Financial Year 2020-21**.

2. **The State Government must transfer these funds to Uttarakhand Rural Roads Development Agency (URRDA) within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases.** The State Government is required to endorse a copy of the release order to the Government of India at the following address:

3. **Uttarakhand Rural Roads Development Agency (URRDA), Dehradun** has nominated **Shri Uday Raj Singh, Chief Executive Officer, Uttarakhand Rural Roads Development Agency (URRDA)** as the Empowered Officer.

4. The funds transferred by the State Government to URRDA shall be kept in a separate **Saving Bank Account No. 10587409191 (IFS Code- SBIN0005713, Branch Code-005713) in State Bank of India, First Floor, Windlass Shop G Complex, Rajpur Road, Dehradun.**

5. The URRDA shall utilize the amount released under Administrative Fund as per revised Para 12.2 of the Programme Guidelines vide the Ministry's Circular No. P-12014/1/2014-RC dated 20th May, 2014.

6. No Utilization Certificate is pending from **Uttarakhand Rural Road Development Agency (URRDA)**.

7. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose

8. The Accounts of the grantee institution will be audited by the Comptroller and Auditor General of India and the internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 236 (1) of the General Financial Rules (GFR).

9. The expenditure is debitable to the following Head of Account under **Demand No.85** of the Department of Rural Development during the current financial year **2020-21:-**

- 3601 - Grants-in-aid to State Government (Major Head)
- 06 - Centrally Sponsored Schemes
- 101 - Central Assistance Share
- 30 - Pradhan Mantri Gram Sadak Yojana
- 30.01 - Program Component-PMGSY
- 30.01.35 - Grants for creation of capital assets

10. The Section Officer, PMGSY, Ministry of Rural Development, New Delhi (208139) will be the Drawing and Disbursing Officer for this purpose. The amount mentioned in Para-1 above will be transferred to **State Government of Uttarakhand**.
