Subject: Release of Grants-in-aid (Programme Fund) to State Government of Uttarakhand as 3rd installment (additional fund) of Annual Allocation (AA) for year 2021-22 under Pradhan Mantri Gram Sadak Yojana (PMGSY).

Sir,

I am directed to convey the sanction of the President of India for release of **Rs.196,75,00,000/- (Rupees One Hundred Ninety Six Crore and Seventy Five Lakh only)** to the State Government of Uttarakhand as Central assistance towards 3rd installment (additional fund) of AA, 2021-22 under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the **Financial Year 2021-22**.

2. The above said sanction of **Rs.196.75 crore** is being adjusted under **Regular PMGSY** as per the details given below:

The State Government shall transfer these funds along with the corresponding State share to **Uttarakhand Rural Roads Development Agency (URRDA) within a maximum period of 15 days from the date of receipt of these funds**. In case of non-transfer beyond this period, Central Government would be constrained to stop further releases. The State Government is required to endorse a copy of the release order to the Government of India at the following address:

4. Uttarakhand Rural Roads Development Agency (URRDA), Dehradun has nominated **Shri Uday Raj Singh, Chief Executive Officer**, Uttarakhand Rural Roads Development Agency (URRDA) as the Empowered Officer.

5. The funds transferred by the State Government to URRDA shall be kept in a separate **Saving Bank Account No.30256973236 (IFS Code- SBIN0005713, Branch Code-05713) in State Bank of India, First Floor, Vindlas Complex, Rajpur Road, Dehradun**. It shall be ensured by **Uttarakhand Rural Roads Development Agency (URRDA)** that the Programme Implementation Units (PIUs) in the

districts have ready access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies only for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of **Uttarakhand Rural Roads Development Agency (URRDA)** shall communicate to the Bank, the names of the Authorised Signatories, who will be issuing cheques on the Agency's said Bank Account for the purpose of this sanction.

6. The Empowered officer shall issue standing instructions to the Bank regarding the names of Authorised Payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payment as per the agreed work programme for the respective package.

7. No Utilization Certificate is pending from **Uttarakhand Rural Roads Development Agency (URRDA), Dehradun.**

8. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of **Rule 236(1)** of the General Financial Rules.

9. The expenditure is debit to the following Head of Account under **Demand No.86** of the Department of Rural Development during the current financial year **2021-22:-**

- 3601 - Grants-in-aid to State Government (Major Head)
- 06 - Centrally Sponsored Schemes
- 101 - Central Assistance Share
- 30 - Pradhan Mantri Gram Sadak Yojana
- 30.01 - Program Component-PMGSY

10. The Section Officer, PMGSY, Ministry of Rural Development, New Delhi (208139) will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para-1 above will be transferred to **State Government of Uttarakhand.**
