- 4. The funds transferred by the State Government to URRDA shall be kept in a separate Saving Bank Account No. 10587409191 (IFS Code-SBIN0005713, Branch Code-005713) in State Bank of India, First Floor, Windlass Shop G Complex, Rajpur Road, Dehradun.
- 5. The URRDA shall utilize the amount released under Administrative Fund as per revised Para 12.2 of the Programme Guidelines vide the Ministry's Circular No. P-12014/1/2014-RC dated 20th May, 2014.
- 6. No Utilization Certificate is pending from Uttarakhand Rural Road Development Agency (URRDA).
- 7. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose
- 8. The Accounts of the grantee institution will be audited by the Comptroller and Auditor General of India and the internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211 (1) of the General Financial Rules (GFR).
