**Sub: Release of Grants-in-aid to State Government of Punjab as balance payment of II<sup>nd</sup> Installment under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the year 2016-17.**

Sir,

1.1 I am directed to convey the sanction of the President to the payment of Grants-in-aid amounting to **46,96,12,500/- (Rupees Forty Six Crore, Ninety Six Lakh, Twelve Thousand and Five Hundred Only)** to the State Government of Punjab as Central assistance under PMGSY for the financial year 2016-17.

1.2. The current amount of **Rs. 46.96125 crore** towards part payment of 1<sup>st</sup> installment of phase-XI (**Batch-II**) is released as per the details given below:

1.3. The State Government must transfer these funds to **Punjab Roads & Bridges Development Board (PRBDB)** within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. Besides, the State Government would be liable to pay interest @ 12% for the period of delay beyond the specified period.

1.4. **Punjab Roads & Bridges Development Board (PRBDB), Chandigarh** has nominated Shri Yogesh Gupta, Chief Engineer, as the Empowered Officer. The State Government is required to endorse a copy of the release order to the Government of India at the following address:

1.5. The funds shall be kept in a separate **saving Bank Account No. 10506608012 in State Bank of India, (Branch Code No.3246), IFSC Code-SBIN 0003246, Sector-7, Madhya Marg, Chandigarh.** It shall be ensured by the **Punjab Roads & Bridges Development Board (PRBDB)**, the Programme Implementing Units (PIUs) in the districts have ready access to the funds and the funds held in the specified account are allowed to be utilized only by the Executive Agency/Agencies for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of **PRBDB** shall communicate to the Bank the names of the Authorized Signatories, who will be issuing cheques on the Agency's said Bank Account for the purpose of this sanction.

1.6. No Utilization Certificate is pending from Manipur State Rural Roads Development Agency (MSRRDA). The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose. **Also, the State should ensure that this fund should not be utilized for any new works sanctioned under PMGSY till the Model Code of Conduct is in force.**


1.7. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211(1) of the General Financial Rules.
