2. The Ministry has cleared proposals to the tune of Rs. 11.69 cr under PMGSY-I (vide clearance letter dated 14.12.2017). The present release of Rs. 5 Crore is adjusted against part payment of 1st installment under Batch-I, 2017-18 as per the details given below:

- 3. The UT Administration must transfer these funds to ANDAMAN NICOBAR STATE ROAD DEVELOPMENT COMMITTEE (ANSRDC) within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. Besides, the UT Administration would be liable to pay interest @12% for the period of delay beyond the specified period.
- 4. Andaman Nicobar State Road Development Committee (ANSRDC) has nominated the Chief Engineer (APWD), BRIGADIER AMIT KATHPALIA as the Empowered Officer of ANSRDC. The UT Administration is required to endorse a copy of the release order to the Government of India at the following address:-

5. The funds released by the UT Administration shall be kept in a separate Savings Bank Account No. 37443379591 (IFSC Branch Code No. SBIN0000156), State Bank of India, Mohanpur, Zordin Port Blair-744104. It shall be ensured by the ANSRDC that the Programme Implementing Units (PIUs) in the districts have ready access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies for the purpose of approved works under the Pradhan

Mantri Gram Sadak Yojana. The Empowered Officer of ANSRDC shall communicate to the bank the names of the Authorized Signatories, who will be issuing cheques on the Agency's said bank account for the purpose of this sanction.

- 6. The Empowered Officer shall issue standing instructions to the bank regarding the names of authorized payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.
- 7. Utilization Certificates are pending from Andaman Nicobar State Road Development Committee (ANSRDC). Further releases to the UT Administration would be on submission progress reports and utilization certificates for the funds released in the inception phases of PMGSY.
- 8. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry, in terms of Rule 211(1) and 211 (2) of the General Financial Rules.
- 9. The expenditure is debitable to the following Head of Accounts under **Demand No. 82** Department of Rural Development (2017-2018).
