**Subject: Release of Rs.3,96,65,000 as 1<sup>st</sup> installment of Central Share of Administrative Funds to State Government of Andhra Pradesh for Road Connectivity Project on Left Wing Extremism (RCPLWE) (Batch-II) under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the year 2017-18-reg.**

Sir,

I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to **Rs.3,96,65,000/- (Rupees Three Crore Ninty Six Lakh Sixty Five Thousand only)** to the State Government of Andhra Pradesh under Road Connectivity Project on Left Wing Extremism (RCPLWE) (Batch-II) towards 1<sup>st</sup> Installment of Central Assistance for the Financial Year 2017-18.

2. The amount of Rs.3.9665 Crore is adjusted against the Sanction letter dated 16.2.2018 and the details are given below:

3. The State Government must transfer these funds to **Andhra Pradesh State Rural Roads Development Agency (APSRRDA) under R&B Department** within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. Besides, the State Government would be liable to pay interest @ 12% for the period of delay beyond the specified period. The State Government is required to endorse a copy of the release order to the Government of India at the following address:

4. **Andhra Pradesh State Rural Roads Development Agency (APSRRDA) under R&B Department** has nominated Sri Ch.V.Soma Sekhar Chief Engineer (R&B), NABARD & LWE as the Empowered Officer.

5. The funds released by the State Government shall be kept in a separate Savings **Bank Account No.060610100150825(IFSC Code No.ANDB0000606), Andhra Bank, Main Branch, R.R Appa Rao Road, Near Bodemma Hotel, Vijayawada-520001.**

6. The Empowered Officer shall issue standing instructions to the Bank regarding the names of Authorized Payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.

7. The Accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211 (1) of the General Financial Rules.

8. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose.

9. The expenditure is debit to the following Head of Accounts under **Demand No.82** Department of Rural Development (2017-2018):
