- 5. The ASRB shall utilize the amount released under Administrative Fund as per revised paral2.2 of the programme guidelines issued vide this Ministry's Circular No.P-12014/1/2014-RC dated 20.5.2014.
- No Utilization Certificate is pending from Assam State Road Board (ASRB), Guwahati.
- 7. The Accounts of the grantee institution will be audited by the Comptroller and Auditor General of India and the internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211 (1) of the General Financial Rules.
