I am directed to convey the sanction of the President to the payment of Grants-in-aid amounting to Rs.2,02,50,000 (Rupees Two Crore Two Lakh and Fifty Thousand only) towards 2nd Installment of Administrative Funds to the State Government of Kerala under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the Financial Year 2016-17.

- 5. The funds released by the State Government shall be kept in a separate Savings Bank Account No.10347397292 (IFSC Branch Code No.SBIN0007898), State Bank of India, Nanthencode Branch, P.B. No.6508, LMS Compound, Vikas Bhawan, P.O., Thiruvananthapuram-695033, Kerala.
- 6. No Utilization Certificate is pending from Kerala State Rural Roads Development Agency (KSRRDA).
- 7. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose.

- 8. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the O/o the CCA, Ministry of Rural Development in terms of Rule 211 (1) of the General Financial Rules.
