Subject –Release of Grants-in-aid to State Government of Karnataka under Pradhan Mantri Gram Sadak Yojana-II (PMGSY-II) for the year 2016-17.

Sir,

1.1 I am directed to convey the sanction of the President to the payment of Grants-in-aid amounting to **Rs.59,99,50,000/-** (Rupees Fifty Nine Crore Ninety Nine Lakh and Fifty Thousand only) to the State Government of Karnataka as Central assistance under Pradhan Mantri Gram Sadak Yojana-II (PMGSY-II) for the Financial Year 2016-17.

1.2 The amount of **Rs.59.995 crore** is towards part payment of 2nd instalment under PMGSY-II as per the details given below:

2. The State Government must transfer these funds to Karnataka Rural Road Development Agency within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. Besides, the State Government would be liable to pay interest @ 12% for the period of delay beyond the specified period.

3. Karnataka Rural Road Development Agency (KRRDA) has nominated **Shri Sanjeev V Maraddi, Superintending Engineer as the Officer-in-charge of Chief Operating Officer of KRRDA.** The State Government is required to endorse a copy of the release order to the Government of India at the following address:-

4. The funds released by the State Government shall be kept in a separate **Savings Bank Account No.04362170000018** in Syndicate Bank, J-652, 1st Floor, Near Navrang Junction, Dr. Rajkumar Road, Rajajinagar 2nd Stage, Bangalore-560010 (IFSC Code No. SYNB0000436), Karnataka. It shall be ensured by the Karnataka Rural Road Development Agency (KRRDA) that the Programme Implementing Units (PIUs) in the districts have access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana-II. The Chief Operating Officer of Karnataka Rural Road Development Agency (KRRDA) shall communicate to the bank the names of the Authorized Signatories, who will be issuing cheques on the Agency's said bank account for the purpose of this sanction.

The Officer-in-charge of Chief Operating Officer shall issue standing instructions to the bank regarding the names of authorized payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.

6. No Utilization Certificate is pending from Karnataka Rural Road Development Agency (KRRDA).

7. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the O/o the CCA of the Ministry of Rural Development in terms of Rule 211 (1) of the General Financial Rules.

8. The expenditure is debit to the following Head of Accounts under **Demand No.75** Department of Rural Development (2016-2017).
