I am directed to convey the sanction of the President to the payment of Grants-in-aid amounting to Rs.3,09,43,50,000 /- (Rupees Three Hundred and Nine crore Forty Three Lakh and Fifty Thousand only) to the State Government of Maharashtra as Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the Financial Year 2016-17.

2. Rs.309.435 crore now being released shall be adjusted towards Programme Fund as part payment of 1<sup>st</sup> instalment under PMGSY-II (Batch-II) in the following manner:-

- 3. The State Government must transfer these funds to Maharashtra Rural Roads Development Association within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. Besides, the State Government would be liable to pay interest @ 12% for the period of delay beyond the specified period.
- 4. Maharashtra Rural Roads Development Association (MRRDA) has nominated **Shri V.D Palve**, Chief Engineer (PMGSY) & Empowered Officer (MRRDA), Government of Maharashtra. The State Government is required to endorse a copy of the release order to the Government of India at the following address:-

5. The funds released by the State Government shall be kept in a separate Savings Bank Account No.10768099150 (IFSC Branch Code No.SBIN0008586), State Bank of India, Madame Cama Road Branch, Post Bag No.11588, Nariman Point, Mumbai-400021, Maharashtra. It shall be ensured by the Maharashtra Rural Roads Development Association that the Programme Implementing Units (PIUs) in the districts have access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of Maharashtra Rural Roads Development Association (MRRDA) shall communicate to the bank the names of the Authorized Signatories, who will be issuing cheques on the Agency's said bank account for the purpose of this sanction.

- The Empowered Officer shall issue standing instructions to the bank regarding the names of authorized pavees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.
- No Utilization Certificate is pending from Maharashtra Rural Roads Development Association (MRRDA).
- The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the O/o the CCA, Ministry of Rural Development in terms of Rule 211 (1) of the General Financial Rules.
