Sub: Release of Administrative Fund to the State Government of Manipur under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the year 2017-18.

Sir,

I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to **Rs.3,28,50,000 (Rupees Three Crore, Twenty Eight Lakh and Fifty Thousand only)** as 1st installment towards Administrative Fund to the State Government of Manipuras Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the **Financial Year 2017-18.**

2. The State Government must transfer these funds to **Manipur State Rural Roads Development Agency (MSRRDA)** within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may consider to stop further releases. Besides, the State Government would be liable to pay interest @ 12% for the period of delay beyond the specified period. The State Government is required to endorse a copy of the release order to the Government of India at the following address:


3. Manipur State Rural Roads Development Agency (MSRRDA) has nominated Shri Thokchom Nandakishore Singh, Chief Engineer, RED (MSRRDA) as Empowered Officer of MSRRDA.

4. The funds transferred by the State Government to MSRRDA shall be kept in a separate **Saving Bank Account No.10329732529 (IFSC Branch Code No. SBIN0004562), State Bank of India, Imphal Secretariat Branch-795001, Manipur.**

5. The MSRRDA shall utilize the amount released under Administrative Fund as per revised para12.2 of the programme guidelines issued vide this Ministry's Circular No.P-12014/1/2014-RC dated 20.5.2014.

6. No Utilization Certificate is pending from **Manipur State Rural Roads Development Agency (MSRRDA).**


