**Sub: Release of Grants-in-aid under 2<sup>nd</sup> installment of Programme Fund to State Government of Mizoram under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the year 2017-18.**

Sir,

I am directed to convey the sanction of the President to the payment of Grants-in-aid amounting to **Rs. 154,32,00,000 /-** (*Rupees One Fifty Four Crore and Thirty Two Lakh only*) to the State Government of Mizoram as Central assistance towards 2<sup>nd</sup> Installment under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the Financial Year 2017-18.

2. The present release of **Rs. 154.32 Crore** is adjusted against **part payment of 1<sup>st</sup> installment under Batch-I, 2016-17** as per the details given below:

3. The State Government must transfer these funds to Mizoram State Rural Roads Development Agency (MiRRDA) within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. Besides, the State Government would be liable to pay interest @12% for the period of delay beyond the specified period.

4. Mizoram State Rural Roads Development Agency (MiRRDA) has nominated Shri R. Lalrintluanga as the Empowered Officer of MiRRDA. The State Government is required to endorse a copy of the release order to the Government of India at the following address:-

5. The funds released by the State Government shall be kept in a separate Savings Bank Account No. 10763514312 (IFSC Branch Code No.SBIN0001539), State Bank of India, Solomon's Cave, Zordin Square, Aizawl, Mizoram-796001. It shall be ensured by the Mizoram State Rural Roads Development

 P.T.O

Agency (MiRRDA) that the Programme Implementing Units (PIUs) in the districts have ready access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of Mizoram State Rural Roads Development Agency (MiRRDA) shall communicate to the bank the names of the Authorized Signatories, who will be issuing cheques on the Agency's said bank account for the purpose of this sanction.

6. The Empowered Officer shall issue standing instructions to the bank regarding the names of authorized payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.

7. No Utilization Certificate is pending from **Mizoram State Rural Roads Development Agency (MiRRDA)**.

8. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211(1) of the General Financial Rules.

9. The expenditure is debitable to the following Head of Accounts under **Demand No. 82** Department of Rural Development (2017-2018).
