Subject: Release of funds to the National Rural Roads Development Agency (NRRDA) for payment of interest to NABARD for the period ending 31st December, 2016 -reg.

Sir,

I am directed to convey the sanction of the President of India to the payment of an amount of **Rs. 16,98,63,833/- (Rupees sixteen crore ninety eight Lakh sixty three thousand eight hundred thirty three only)** as 3rd Instalment, due on 1st January, 2017, to National Rural Roads Development Agency (NRRDA) for making payment of interest to National Bank for Agriculture and Rural Development (NABARD) for the period ending 31st December, 2016. This interest amount is required to be paid to NABARD in terms of tripartite Memorandum of Agreement dated 27th September, 2007 signed by the Ministry of Rural Development, NRRDA and NABARD for implementation of Pradhan Mantri Gram Sadak Yojana (PMGSY).

2. The funds shall be kept in current account No.61188132824 in the State Bank of Bikaner & Jaipur (10936), Krishi Bhawan, New Delhi (IFSC Code No.-SBBJ0010936) of National Rural Roads Development Agency, NRRDA. The interest accrued and funds over and above the actual interest, if any, shall be adjusted towards further payment of interest to NABARD. NRRDA shall ensure that the payment of interest amount is made to NABARD in time.

3. National Rural Roads Development Agency (NRRDA) will submit the utilization certificate duly countersigned by the competent authority to this Ministry alongwith the audit report.


