6. The funds transferred by the State Government to OSRRA shall be kept in a separate Saving Bank Account No. 37370021491 (IFS Code-SBIN0000041) in the State Bank of India, Bhubaneswar Main Branch, Odisha-751009. It shall not be transferred to any other account of the

- Agency without approval. It shall be ensured by the State Government that the Programme Implementing Units (PIUs) in the districts have ready access to the funds and the funds held in the specified account are allowed to be utilized only by the Executive Agency/Agencies only for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of Odisha State Rural Connectivity Project Agency (OSRCPA) shall communicate to the Bank, the names of the Authorized Signatories, who will be issuing cheques on the Agency's bank account for the purpose of this sanction.
- The Empowered Officer shall issue standing instructions to the Bank regarding the names of 7. Authorized Payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.
- No Utilization Certificate is pending from Odisha State Rural Connectivity Project Agency (OSRCPA).
- The Accounts of the grantee institution will be audited by the Comptroller and Auditor 9. General of India and the internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211 (1) of the General Financial Rules.
