Subject: Release of 37.639 Crore as 1st installment of Central Share of programme fund to the State of Andhra Pradesh for Road Connectivity Project on Left Extremism (RCPLWE) under PMGSY for the Financial year 2017-18-reg.

Sir,

1. I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to **Rs.37,63,90,000/- (Rupees Thirty Seven Crore Sixty Three Lakh Ninty Thousand only)** to the State Government of Andhra Pradesh for Road Connectivity Project on Left Extremism (RCPLWE) as Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the **Financial Year 2017-18**.

2. The amount of Rs.37.639 Crore adjusted against the Sanction letter dated 6.11.2017, the details are given below:

3. The State Government must transfer these funds to **Andhra Pradesh State Rural Roads Development Agency (APSRRDA)** within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. Besides, the State Government would be liable to pay interest @ 12% for the period of delay beyond the specified period. The State Government is required to endorse a copy of the release order to the Government of India at the following address:

4. **Andhra Pradesh State Rural Roads Development Agency (APSRRDA)** has nominated Shri C.V.S.Ramamurthy as the Empowered Officer of APSRRDA.

5. The funds released by the State Government to APSRRDA shall be kept in a separate **Savings Bank Account No.110510011001045 (IFSC Code No.ANDB 0001105), Andhra Bank, Banjara Hills Branch, Hyderabad-500034**. It shall be ensured by the Andhra Pradesh State Rural Roads Development Agency that the Programme Implementing Units (PIUs) in the districts have access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of Andhra Pradesh State Rural Roads Development Agency (APSRRDA) shall communicate to the bank the names of the Authorized Signatories, who will be issuing cheques on the Agency's said bank account for the purpose of this sanction.

6. The Empowered Officer shall issue standing instructions to the Bank regarding the names of Authorized Payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.

7. The Accounts of the grantee institution will be audited by the Comptroller and Auditor General of India and the internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211 (1) of the General Financial Rules.

8. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose.

9. The expenditure is debitible to the following Head of Accounts under **Demand No.82** Department of Rural Development (2017-2018):

- 3601 - Grants-in-aid to State Governments (Major Head).
- 06 - Centrally Sponsored Schemes
- 101 - Central Assistance Share
- 30 - Pradhan Mantri Gram SadakYojana
- 30.02 - Roads Project for LWE affected Areas
- 30.02.35 - Grants for creation of Capital assets

10. The Pay & Accounts Officer, Ministry of Rural Development will be the Drawing and Disbursing Officer for this purpose. The amount mentioned in Para-1 above will be transferred to State Government of Madhya Pradesh.
