**Subject: Release of Rs.614.29 Crore as part payment of 2<sup>nd</sup> installment of Phase-VIII, 2008-09 of Regular PMGSY Grants-in-aid to the State Government of Odisha for the year 2017-18 under Pradhan Mantri Gram Sadak Yojana- reg.**

Sir,

I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to **Rs. 614,29,00,000/- (Rupees Six Hundred Fourteen Crore Twenty Nine Lakh only)** to the State Government of Odisha as Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the **Financial Year 2017-18**.

2. The amount of Rs. 614.29 crore released in the present sanction is adjusted as per the details given below:

#Rs. 202.4149Cr. was released vide this Ministry's letter of even no dated 06.08.2009 at file P-17024/20/2007-RC, Rs. 300 Cr. released vide this Ministry's letter of even no dated 29.09.2009, Rs.250 Cr. dated 08.12.2009, Rs.200 Cr. dated 05.01.2010, Rs. 10 Cr. dated 08.02.2010, Rs.152 Cr. dated 15.03.2010, Rs, 191 Cr. dated 30.03.2010, Rs.230 Cr. dated 25.05.2010, Rs. 59.12425 Cr. dated 23.06.2010 at file P-17024/20/2008-RC and **Rs 306.285 Crore was released vide Ministry's letter of even no. dated 31<sup>st</sup> July, 2017.**

3. The State Government must transfer these funds to **Odisha State Rural Road Agency (OSRRA)** within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. Besides, the State Government would be liable to pay interest @ 12% for the period of delay beyond the specified period. The State Government is required to endorse a copy of the release order to the Government of India at the following address:

4. **Odisha State Rural Road Agency (OSRRA)** has nominated Shri Bharat Chandra Pradhan, Chief Engineer ( PMGSY) and the Empowered Officer of Odisha State Rural Road Agency (OSRRA).

5. The funds transferred by the State Government to OSRRA shall be kept in a separate saving **Bank Account No. 10872161766 (IFS Code: SBIN0041) in State Bank of India, Bhubaneshwar Main Branch, District Khurda, Odisha – 751009.** It shall be ensured by **Odisha State Rural Road Agency**

(OSRRA) that the Programme Implementation Units (PIUs) in the districts have ready access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies only for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of the **Odisha State Rural Road Agency (OSRRA)** shall communicate to the Bank, the names of the Authorised Signatories, who will be issuing cheques on the Agency's Bank account for the purpose of this sanction.

6. The Empowered Officer shall issue standing instructions to the Bank regarding the names of Authorized Payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.

7. No Utilization Certificate is pending from Odisha State Rural Road Agency(OSRRA).

8. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose.

9. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211(1) of the General Financial Rules.

10. The expenditure is debitable to the following Head of Accounts under **Demand No.82** Department of Rural Development (2017-2018):

11. The Pay & Accounts Officer, Ministry of Rural Development will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para-1 above will be transferred to State Government of Odisha.
