**Subject- Release of Grants-in-aid to State Government of Sikkim under Pradhan Mantri Gram Sadak Yojana (PMGSY).**

Sir,

1.1 I am directed to convey the sanction of the President to the payment of Grants-in-aid amounting to **Rs. 115,83,37,500 (Rupees One Hundred Fifteen Crore Eighty Three Lakh Thirty Seven Thousand and Five Hundred only)** to the State Government of Sikkim as Central assistance during 2017-18 under Pradhan Mantri Gram Sadak Yojana (PMGSY).

1.2 Out of Rs 115.83375 crore, Rs 88.0192 Cr. is towards payment of 2<sup>nd</sup> installment under Batch-I, 2014-15 and Rs 27.81455 Cr. towards part payment of 1<sup>st</sup> installment under Batch-I, 2016-17 as per the following details:-

2.1 The funds will be released to the State Government as per the Bank details given below:-

2.2 The State Government must transfer these funds to Sikkim Rural Roads Development Agency (SRRDA) within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. Besides, the State Government would be liable to pay interest @12% for the period of delay beyond the specified period.

3. The funds released by the State Government shall be kept in a separate savings Bank Account No. 11018614444 (IFS Code No.SBIN0000232), State Bank of India, Gangtok Branch, M.G Road, Sikkim-737101. It shall be ensured by the Sikkim Rural Roads Development Agency (SRRDA) that the Programme Implementing Units (PIUs) in the districts have access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of Sikkim Rural Roads Development Agency (SRRDA) shall communicate to the bank the names of the Authorized Signatories, who will be issuing cheques on the Agency's said bank account for the purpose of this sanction.

4. Sikkim Rural Roads Development Agency has nominated **Shri Shital Pd. Pradhan, Chief Executive Officer/Chief Engineer**, Rural Management & Development Department, as the Empowered Officer of Sikkim Rural Roads Development Agency (SRRDA). The State Government is required to endorse a copy of the release order to the Government of India at the following address:-

5. The Empowered Officer shall issue standing instructions to the bank regarding the names of authorized payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.

6. No Utilization Certificate is pending from **Sikkim Rural Roads Development Agency (SRRDA)**.

7. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose

8. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211(1) of the General Financial Rules.

9. The expenditure is debitable to the following Head of Accounts under **Demand No.82** Department of Rural Development (2017-2018):
