5. No Utilization Certificate is pending from the recipient organization in respect of the scheme under which funds is released.


6. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year.

8. This issues with the concurrence of the Integrated Finance Division vide their **U.O. No. 1285/Finance/2016-17 dated 28.03.2017.**


