Sir,

I am directed to convey the sanction of the President to the payment of Grants-in-aid amounting to Rs.2,33,30,000 (Rupees Two Crore Thirty Three Lakh Thirty Thousand only) as 1st Installment towards Administrative Funds to the State Government of Telanagana under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the Financial Year 2016-17.

- 2. The State Government must transfer these funds to Telangana State Rural Roads Development Agency (TSRRDA) within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. Besides, the State Government would be liable to pay interest @ 12% for the period of delay beyond the specified period.

- 5. The funds released by the State Government shall be kept in a separate Savings Bank Account No.110510100114258 (IFSC Code.ANDB0001105), Andhra Bank, Banjara Hills Branch, 8-2-626/51 Road No.1, Reliance Classic Building, Banjara Hills, Hyderabad-500034.
- 6. No Utilization Certificate is pending from Telangana State Rural Roads Development Agency (TSRRDA).
- 7. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose.
