- 1.1 I am directed to convey the sanction of the President to the payment of Grants-in-aid amounting to Rs.57,47,84,000 (Rupees Fifty Seven Crore Forty Seven Lakh and Eighty Four Thousand only) to the State Government of Tamil Nadu as Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) during the Financial Year 2017-18.
- 1.2 The amount of Rs. 57.4784 crore is towards 1st Installment under Phase-IX as follows:-

- *Rs.40.2691 cr released vide S.O dt. 21.12.2016, Rs.1.1761 cr interest accrued for 2015-16 adjusted under Phase-IX vide S.O dt. 21.12.2016 and Rs. 55.7661 cr released vide S.O dt. 28.02.2017.
- 2. The State Government must transfer these funds to Tamil Nadu Rural Housing and Infrastructure Development Corporation within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. Besides, the State Government would be liable to pay interest @ 12% for the period of delay beyond the specified period.
- 3. Tamil Nadu Rural Housing and Infrastructure Development Corporation (TNRHIDC) has nominated Shri K.Baskaran, Director, Rural Development & Panchayat Raj Department, Government of Tamil Nadu as the Empowered Officer. The State Government is required to endorse a copy of the release order to the Government of India at the following address:-

4. The funds released by the State Government shall be kept in a separate Savings Bank Account No.10885934245 (IFSC Branch Code No.SBIN0013241), State Bank of India, Small and Medium Enterprises (SME) Branch, No.84, Rajaji Salai, Chennai-600001, Tamil Nadu. It shall be ensured by the Tamil Nadu Rural Housing and Infrastructure Development Corporation that the Programme Implementing Units (PIUs) in the districts have access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of Tamil Nadu Rural Housing and Infrastructure Development Corporation (TNRHIDC) shall communicate to the bank the names of the Authorized Signatories, who will be issuing cheques on the Agency's said bank account for the purpose of this sanction.

- 5. The Empowered Officer shall issue standing instructions to the bank regarding the names of authorized payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.
- 6. No Utilization Certificate is pending from Tamil Nadu Rural Housing and Infrastructure Development Corporation (TNRHIDC).
- 7. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose.
- 8. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the O/o the CCA, Ministry of Rural Development in terms of Rule 211 (1) of the General Financial Rules.
- 9. The expenditure is debitable to the following Head of Accounts under **Demand No. 82** Department of Rural Development (2017-2018).
