- 1. I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to Rs. 488,64,50,000/- (Rupees Four Hundred Eighty Eight Crore Sixty Four Lakh and Fifty Thousand Only) to the State Government of Uttar Pradesh as Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the Financial Year 2016-17.
- 2. The amount of Rs. 488.6450 crore is towards part payment of 2<sup>nd</sup> installment under Regular PMGSY (Clearance dated 3<sup>rd</sup> December, 2012). The amount of Rs. 488.6450 crore is adjusted as per the details given below:

3. The State Government must transfer these funds to **Uttar Pradesh Rural Roads Development Agency (UPRRDA)** within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. Besides, the State Government would be liable to pay interest @ 12% for the period of delay beyond the specified period. The State Government is required to endorse a copy of the release order to the Government of India at the following address:

- 4. **Uttar Pradesh Rural Roads Development Agency (UPRRDA)** has nominated Shri S.V.S. Ranga Rao, Chief Executive Officer, UPRRDA as the Empowered Officer.
- Bank Account No. 10616665805 in State Bank of India, Jawahar Bhavan, (Branch Code No. 6144),(IFSCodeNo.SBIN0006144), Lucknow. It shall not be transferred to any other account of the Agency without approval. It shall be ensured by the State Government that the Programme Implementation Units (PIUs) in the districts have ready access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies only for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of the Uttar Pradesh Rural Roads Development Agency (UPRRDA), shall communicate to the Bank, the names of the Authorised Signatories, who will be issuing cheques on the Agency's Bank account for the purpose of this sanction.

- 6. The Empowered Officer shall issue standing instructions to the Bank regarding the names of Authorized Payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.
- 7. No Utilization Certificate is pending from Uttar Pradesh Rural Roads Development Agency (UPRRDA), Lucknow.
- 8 The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose
- 9. The Accounts of the grantee institution will be audited by the Comptroller and Auditor General of India and the internal Audit of the O/o the CCA of the Ministry of Rural Development in terms of Rule 211 (1) of the General Financial Rules.
- 10. The expenditure is debitable to the following Head of Account under Demand No.75-Department of Rural Development during the current financial year (2016-17):-

3601 - Grants-in-aid to State Government (Major Head)
02 - Grants for State Plan Schemes (Sub-major Head)
