Subject: – Release of Grants-in-aid to State Government of West Bengal under Pradhan Mantri Gram Sadak Yojana (PMGSY) towards Administrative Fund for the year 2017-18.

Sir,

I am directed to convey the sanction of the President to the payment of Grants-in-aid amounting to **Rs.9,61,50,000/- (Rupees Nine Crore Sixty One Lakh Fifty Thousand Only)** towards 1st Installment of Administrative Fund to the State Government of West Bengal as Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the financial year 2017-18.

2. The State Government must transfer these funds to West Bengal State Rural Development Agency (WBSRDA) within 3 days positively from the date of receipt of these funds. In case of non transfer beyond this period, Central Government may be considered to stop further releases. Besides, the State Government would be liable to pay interest @12% for the period of delay beyond the specified period. The State Government is requested to endorse the copy of the release order to the Central Government addressed as under;



3. West Bengal State Rural Development Agency (WBSRDA) has nominated Shri S. Chakrabarti, Additional Chief Executive Officer & Empowered Officer of West Bengal State Rural Development Agency (WBSRDA), 63, N.S. Road, Jessop Building (1st Floor), Kolkata.

4. The funds released by the State Government shall be kept in a separate savings Bank Account No. 11143673879 (IFSC Code No.SBIN0014524), State Bank of India, Specialised Institutional Banking Branch, Code(14524), 4th Floor, Block 'C' & 'D' & 6th Floor, Block 'C' Samridhi Bhavan, 1 Strand Road, Kolkata-700001. It shall be ensured by the West Bengal State Rural Development Agency (WBSRDA) that the Programme Implementing Units (PIUs) in the districts have access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of West Bengal State Rural Development Agency (WBSRDA) shall communicate to the bank the names of the Authorised Signatories, who will be issuing cheques on the Agency's bank account for the purpose of this sanction.

5. The Empowered Officer shall issue standing instructions to the bank regarding the names of authorized payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.

6. No Utilization Certificate is pending from West Bengal State Rural Development Agency (WBSRDA).



7. Utilisation Certificate should be submitted within 12(twelve) months of the closure of the financial year which shall include interest accrued. Interest accrued should be computed based on the details of the ledger accounts for the purpose.

8. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211 (1) of the General Financial Rules.

9. The expenditure is debit to the following Head of Accounts under **Demand No.82** Department of Rural Development (2017-2018):

- 3601 - Grants-in-aid to State Governments (Major Head).
- 06 - Centrally Sponsored Schemes
- 101 - Central Assistance/Share
- 30 - Pradhan Mantri Gram Sadak Yojana
- 30.01 - Programme Component- PMGSY
- 30.01.35 - Grants for creation of Capital assets

10. The Pay & Accounts Officer, Ministry of Rural Development will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para-1 above will be transferred to State Government of West Bengal.


