**Subject – Release of Grants-in-aid to State Government of Assam under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the year 2016-17.**

Sir,

I am directed to convey the sanction of the President to the payment of Grants-in-aid amounting to **Rs.77,02,00,000/- (Rupees Seventy Seven crore and Two Lakh only)** to the State Government of Assam under **Vote on Account (April-May, 2016)** as Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the Financial Year 2016-17. This amount would be adjusted against a specific Phase/Batch during the regular release of 1<sup>st</sup> installment under PMGSY for the financial year 2016-17.

2. **The State Government must transfer these funds to Assam State Road Board, Guwahati within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. Besides, the State Government would be liable to pay interest @ 12% for the period of delay beyond the specified period.**

3. Assam State Road Board (ASRB) has nominated Shri S. M. Hassan, Additional Chief Engineer, PWD (Roads), Government of Assam, Chandmari, Guwahati-781003 as the Empowered Officer. The State Government is required to endorse a copy of the release order to the Government of India at the following address:-

4. The funds released by the State Government shall be kept in a separate Savings **Bank Account No.10566991446 (IFSC Branch Code No. SBIN0000221), State Bank of India, New Guwahati Branch, Guwahati-781021.** It shall be ensured by the Assam State Road Board (ASRB) that the Programme Implementing Units (PIUs) in the districts have access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of Assam State Road Board (ASRB) shall communicate to the bank the names of the Authorized Signatories, who will be issuing cheques on the Agency's said bank account for the purpose of this sanction.

5. The Empowered Officer shall issue standing instructions to the bank regarding the names of authorized payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.

6. No Utilization Certificate is pending from **Assam State Road Board (ASRB).**

7. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211 (1) of the General Financial Rules.


8. The expenditure is debitible to the following Head of Accounts under **Demand No.75** Department of Rural Development (2016-2017).

- 3601 - Grants-in-aid to State Government (Major Head).
- 02 - Grants for State Plan Schemes (Sub-Major Head)
- 420 - District & Other Roads- Pradhan Mantri Gram Sadak Yojana (Minor Head)
