**Subject – Release of Agency Fees to M/s National Buildings Construction Corporation Limited (NBCC), Bihar under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the year 2016-17.**

Sir,

I am directed to convey the sanction of the President of India for release of an amount of **Rs.17,83,29,000/- (Rupees Seventeen Crore Eighty Three Lakh Twenty Nine Thousand only)** to the State Government of Bihar as the Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the payment of Agency Fees to **M/s National Buildings Construction Corporation Limited (NBCC)** for financial year 2016-17.

2. The State Government must transfer these funds within 3 working days positively from the date of receipt of these funds to Bihar State Rural Road Development Agency (BRRDA) which in turn would transfer these funds to M/s National Buildings Construction Corporation Limited (NBCC) having their registered office at NBCC Bhavan Lodhi Road, New Delhi and Central Zone Office at 4<sup>th</sup> Floor, Maurya Tower, Maurya Lok Complex, Patna.

3. **The funds will be transferred by the State Government to Bihar State Rural Road Development Agency (BRRDA) in their saving Bank Account No. 1111137916 (Old Account No. 01100050390) (Branch Code No. 006379), IFSC Code SBIN0006379 in State Bank of India, Bailey Road Branch, Patna.** In case of non transfer beyond the stipulated period in para-2 above, Central Government may be constrained to stop further releases to the State. Besides, the State Government would be liable to pay interest @12% per annum for the period of delay beyond the specified period to BRRDA. The State Government is required to endorse the copy of the transfer of funds to the Government of India at the following address:

4. Thereafter, the above funds, along with the interest if any, will be transferred by the BRRDA within 3 working days positively from the date of receipt of these funds to NBCC to their current account No.352401010035007, Union Bank of India, Lodhi Colony, New Delhi, (Branch Code-535249) MICR Code 110026017 (IFS Code-UBIN535249). In case of non transfer beyond the stipulated period in para-2 above, Central Government may be constrained to stop further releases to the State. Besides, the BRRDA would be liable to pay interest @12% per annum for the period of delay beyond the specified period to NBCC. The BRRDA is required to endorse the copy of the transfer of funds to the Government of India to the address mentioned in para-3 above.

5. This release to NBCC is towards agency fee in terms of clause 11.1 of the Tripartite Agreement dated 31<sup>st</sup> August, 2004, signed between M/s National Building Construction Corporation Limited, New Delhi, Rural Development Department, Government of Bihar and the Ministry of Rural Development. This amount will be adjusted towards 10% of the total project cost of awarded works.

6. No Utilization Certificate is pending from NBCC.

7. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211 (1) of the General Financial Rules.

8. The expenditure is debitible to the following Head of Accounts under Demand No. 75 Department of Rural Development (2016-2017).
