3. The expenditure is debitable to the following Head of Account under Demand No.75 of the Department of Rural Development for the financial year 2016-17:



5. No Utilisation Certificate is pending from the recipient organization in respect of the scheme under which funds is released.


6. The Accounts of the grantee institution will be audited by the Comptroller and Auditor General of India and the internal Audit of the Principal Accounts Office of the Ministry.
