**Subject – Release of Grants-in-aid to State Government of Tripura under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the year 2016-17.**

Sir,

I am directed to convey the sanction of the President to the payment of Grants-in-aid amounting to **Rs. 57,29,00,000 (Rupees Fifty Seven Crore and Twenty Nine Lakh only)** to the State Government of Tripura under **Vote on Account (April-May, 2016)** as Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the Financial Year 2016-17. This amount would be adjusted against a specific Phase/Batch during the regular release of 1<sup>st</sup> instalment under PMGSY for the financial year 2016-17.

2. **The State Government must transfer these funds to Tripura Rural Road Development Agency (TRRDA) within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. Besides, the State Government would be liable to pay interest @12% for the period of delay beyond the specified period.**

3. Tripura Rural Road Development Agency (TRRDA) has nominated Shri S. Bhattacharya, Chief Engineer as the Empowered Officer of TRRDA. The State Government is required to endorse a copy of the release order to the Government of India at the following address:-

4. The funds released by the State Government shall be kept in a separate Savings **Bank Account No. 10221183170 (IFSC Branch Code No. SBIN0004545), State Bank of India, Kunjavan, Agartala, West Tripura.** It shall be ensured by the Tripura Rural Road Development Agency (TRRDA) that the Programme Implementing Units (PIUs) in the districts have access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of Tripura Rural Road Development Agency (TRRDA) shall communicate to the bank the names of the Authorised Signatories, who will be issuing cheques on the Agency's said bank account for the purpose of this sanction.

5. The Empowered Officer shall issue standing instructions to the bank regarding the names of authorized payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.

6. No Utilization Certificate is pending from **Tripura Rural Road Development Agency (TRRDA).**

7. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211(1) of the General Financial Rules.


8. The expenditure is debitable to the following Head of Accounts under **Demand No. 75** Department of Rural Development (2016-2017).
